THIRDLY, A STRONG LITERATURE REVIEW CAN INFORM YOUR OWN RESEARCH DESIGN AND METHODOLOGY, DRAWING LESSONS FROM PREVIOUS STUDIES. FINALLY, IT DEMONSTRATES YOUR ABILITY TO CRITICALLY

## KEY STAGES BEFORE WRITING: PREPARATION AND RESEARCH

6. HOW DOES THIS SOURCE RELATE TO OTHER WORKS ON THE TOPIC, AND WHAT UNIQUE CONTRIBUTION DOES IT MAKE?

THIS CRITICAL ANALYSIS MOVES BEYOND MERE SUMMARIZATION, ALLOWING YOU TO IDENTIFY STRENGTHS, WEAKNESSES, CONTROVERSIES, AND GAPS IN THE EXISTING BODY OF LITERATURE.

## STRUCTURING YOUR LITERATURE REVIEW ASSIGNMENT

A WELL-STRUCTURED LITERATURE REVIEW PROVIDES A CLEAR, LOGICAL NARRATIVE THAT GUIDES THE READER THROUGH THE EXISTING SCHOLARSHIP. THIS SECTION IS CRUCIAL FOR ESTABLISHING THE RELEVANCE AND DIRECTION OF YOUR ANALYSIS.

## DEVELOPING COHERENT BODY PARAGRAPHS

THE BODY OF YOUR LITERATURE REVIEW IS WHERE YOU PRESENT YOUR CRITICAL ANALYSIS AND SYNTHESIS OF THE SELECTED SOURCES. EACH PARAGRAPH OR SECTION SHOULD FOCUS ON A PARTICULAR THEME, THEORY, OR ARGUMENT, INTEGRATING MULTIPLE SOURCES TO SUPPORT YOUR POINTS. INSTEAD OF MERELY SUMMARIZING INDIVIDUAL ARTICLES, STRIVE TO IDENTIFY CONNECTIONS, CONTRASTS, AND CONTROVERSIES AMONG THEM. USE TOPIC SENTENCES TO INTRODUCE THE MAIN IDEA OF EACH PARAGRAPH, FOLLOWED BY EVIDENCE FROM YOUR SOURCES, AND THEN YOUR OWN ANALYTICAL COMMENTARY. - OFFER IMPLICATIONS FOR FUTURE RESEARCH OR PRACTICE BASED ON THE LITERATURE REVIEWED.

A STRONG CONCLUSION PROVIDES CLOSURE AND REINFORCES THE VALUE OF YOUR CRITICAL ANALYSIS, EFFECTIVELY BRINGING TOGETHER ALL THE ELEMENTS OF HOW TO WRITE A LITERATURE REVIEW ASSIGNMENT.

INSTEAD OF LISTING "AUTHOR A SAID X, AUTHOR B SAID Y," AIM FOR "BOTH AUTHOR A AND AUTHOR B FOUND X, BUT AUTHOR C'S STUDY CONTRADICTED THIS, SUGGESTING Y DUE TO Z METHODOLOGY." THIS APPROACH DEMONSTRATES DEEPER CRITICAL THINKING.

## INTEGRATING SOURCES SEAMLESSLY

THE SMOOTH INTEGRATION OF SOURCES IS VITAL FOR MAINTAINING FLOW AND READABILITY. AVOID DROPPING QUOTES OR PARAPHRASES INTO YOUR TEXT WITHOUT PROPER INTRODUCTION OR EXPLANATION. USE SIGNAL PHRASES TO INTRODUCE

THIS ENSURES YOUR VOICE REMAINS CENTRAL TO THE REVIEW.

## MAINTAINING ACADEMIC TONE AND VOICE

A LITERATURE REVIEW DEMANDS A FORMAL, OBJECTIVE, AND ACADEMIC TONE. AVOID INFORMAL LANGUAGE, CONTRACTIONS, SLANG, AND PERSONAL OPINIONS (UNLESS EXPLICITLY SUPPORTED BY EVIDENCE). LOOK FOR OPPORTUNITIES TO STRENGTHEN YOUR TOPIC SENTENCES, IMPROVE PARAGRAPH DEVELOPMENT, AND USE LINKING WORDS AND PHRASES TO CREATE A SEAMLESS NARRATIVE. ENSURE THAT YOUR ARGUMENTS BUILD UPON EACH OTHER LOGICALLY, GUIDING THE READER THROUGH YOUR INTERPRETATION OF THE LITERATURE.

## CHECKING FOR GAPS AND REDUNDANCIES

ELIMINATING REDUNDANCIES STREAMLINES YOUR REVIEW, MAKING IT MORE IMPACTFUL AND CONCISE.

## PROOFREADING FOR GRAMMAR AND SPELLING
