• Two Authors: Always cite both authors' last names separated by an ampersand (&) in parenthetical citations, and the word "and" in narrative citations.

Narrative: Lee and Kim (2021) argue...

• Three or More Authors: For three or more authors, use "et al." after the

first author's last name for all in-text citations, regardless of whether it's the first time you're citing the source.

Parenthetical: (Garcia et al., 2019)

Narrative: Garcia et al. (2019) found...

# Citing Specific Pages or Sections

When you refer to a specific part of a source, such as a direct quotation, a paraphrase of a particular idea, or a specific table or figure, it is crucial to include a page number or other locator in your in-text citation. This helps readers locate the exact information you are referencing. For journal articles, page numbers are most common.

Example (Direct Quote):

"The methodology employed an innovative mixed-methods approach" (Davies, 2022, p. 78).

Example (Paraphrase):

The study's unique research design integrated both qualitative and quantitative data collection (Davies, 2022, p. 78).

If the source does not have page numbers (e.g., some online articles), use paragraph numbers (para.), section names, or a combination thereof.

# Building the Reference List Entry for Journal Articles

The reference list, appearing at the end of your paper, provides the full bibliographic information for every source cited in your text. Each entry in the reference list corresponds to an in-text citation. For journal articles, the format is highly specific, ensuring all critical details are presented consistently. # Journal Article with Three to Twenty Authors

For articles with three to twenty authors, all author names are listed in the reference list entry. This is a change from APA 6th Edition, which used "et al." for more than seven authors. Now, "et al." is only used for in-text citations with three or more authors.

### Example:

Williams, L. S., Davis, R. M., Garcia, E. P., Chen, F. L., Smith, T. J., & Brown, K. A. (2021). Advances in neuroscience research: A comprehensive review. *Brain Research Bulletin*, 170, 55-68.

# Journal Article with Twenty-One or More Authors

If a journal article has twenty-one or more authors, list the first nineteen authors, followed by an ellipsis (...), and then the last author's name. This streamlines very long author lists while still giving credit to the contributors.

#### Example:

Anderson, S. T., Baker, J. R., Campbell, L. M., Davies, P. Q., Evans, M. N., Foster, O. R., Green, A. B., Harris, C. D., Irvine, E. F., Jones, G. H., King, H. I., Lewis, J. K., Moore, L. P., Nelson, M. Q., Owens, N. R., Patel, O. S., Quinn, P. T., Roberts, Q. U., Scott, R. V., ... Young, Z. W. (2023). Global trends in climate change mitigation strategies. *Environmental Science & Technology*, 57(10), 3801-3815. https://doi.org/10.1021/acs.est.2c07000

### Journal Article Without a DOI

Many older journal articles or those from certain publishers may not have a Digital Object Identifier (DOI). In such cases, if the article was accessed online, provide the URL of the journal's homepage or the database it was retrieved from, if direct URL to the article is not stable.

Example (Print Article, no DOI):

Jones, K. R. (1998). A historical perspective on psychological theory. Journal of Theoretical Psychology, 34(1), 12-25.

## Journal Article Retrieved from a Database (No DOI)

If an article is from a research database and lacks a DOI, and you cannot find it through a general journal URL (e.g., it's an exclusive database item), provide the name of the database. However, APA 7th Edition generally recommends against including database names unless the article is available only in that specific database or has a limited circulation. The most common advice is to provide a stable URL if available, otherwise just list the basic components if it's widely available.

Example (Rarely needed, but if no DOI and article is exclusive to database): Wang, L. (1995). Impact of organizational culture on employee retention.

**Note:** The general guidance for articles without a DOI that are widely available in many databases is to treat them as print versions and omit the retrieval information.

# Journal Article with Supplemental Material

If a journal article includes supplemental materials (e.g., appendices, datasets) that you are specifically referencing, cite the main article, and then describe the supplemental material in the text where you mention it. The reference entry itself remains focused on the main article.

# Advanced Scenarios: Ephemeral Content and Preprints

Some journal articles might initially appear as preprints on servers like arXiv or PsyArXiv before formal peer review and publication. If you cite a preprint, treat it as an unpublished manuscript with a specific URL. Once it's formally published, update your citation to the published version.

For example, in-text: ("The Future of AI," 2023). Reference list: The future of AI in medical diagnostics. (2023). Journal of Medical Innovations, 15(2), 55-68. https://doi.org/xxxx

# Q: Can I use a general URL for a database in my

### reference list?

A: APA 7th Edition generally discourages the use of database URLs in reference list entries. If a journal article has a DOI, always use that. If there is no DOI, but the article is from a well-known academic journal that is widely available in print or across multiple databases, you typically do not need to include any retrieval information (treat it like a print source). Only include a database name or URL if the article is from a specialized database with limited circulation, and it's essential for readers to find it through that specific platform.

# Q: How do I cite an article from a popular magazine vs. a scholarly journal in APA?

For a popular magazine article, you include the month and day (if available) in the publication date, and the article title is not italicized. The magazine title is italicized. For example: Author, A. A. (Year, Month Day). Title of article. Title of Magazine, volume(issue), pages. URL (if online). For a scholarly journal article, only the year is typically included in the date, the article title is not italicized, and the journal title and volume number are italicized. The issue number is in parentheses and not italicized. Example: Author, A. A. (Year). Title of article. Title of Scholarly Journal, volume(issue), pages. DOI.
