CHICAGO ANNOTATIONS TEND TO BE COMPREHENSIVE, PROVIDING DETAILED SUMMARIES AND DISCUSSIONS OF THE SOURCE'S HISTORICAL CONTEXT, ARGUMENTS, AND CONTRIBUTION TO SCHOLARSHIP.
