UNDERSTANDING THE COST OF TEXTBOOKS

- **PRODUCTION COSTS:** THE COSTS ASSOCIATED WITH WRITING, EDITING, AND PRINTING HIGH-QUALITY TEXTBOOKS CAN BE SUBSTANTIAL, CONTRIBUTING TO THE FINAL RETAIL PRICE.

Their position is hypocritical as well, given the fact that economics professors, more than anyone else, have upheld the idea that jobs should be lost, and new ones should be gained, in response to technological changes that promote economic efficiency. There is also irony in the fact that the high tuitions required to maintain traditional classrooms effectively deny a college education to those who cannot afford it. Thus, unsound arguments that traditional lectures are needed to preserve the quality of education actually do not improve the quality of education but have the only real effect of denying education to many people who would otherwise be able to receive it. To address this topic comprehensively, the book goes deep into fundamental questions about what economics professors really do with their time and energy, and what they should be doing in the best interests of their students and of society. These are areas that the profession has needed to address for a long time, but has failed to do so.
