

One content dimension included four themes: change and continuity in U.S. democracy: ideas, institutions, practices, and controversies; the gathering and interaction of peoples, cultures, and ideas; economic and technological changes and their relation to society, ideas, and the environment; and the changing role of the United States in the world. A second content dimension covers eight time periods: Three Worlds and Their Meeting in the Americas (beginnings to 1607); Colonization, Settlement, and Communities (1607 to 1763); The Revolution and the New Nation (1763 to 1815); Expansion and Reform (1801 to 1861); Crisis of the Union: Civil War and Reconstruction (1850 to 1877); Development of Modern America (1865 to 1920); Modern America and the World Wars (1914 to 1945); and Contemporary America (1945 to present). At every grade, the overall geography performance of males was higher than that of females; however, in U.S. history overall performances for males and females was significantly different at 12th grade only where males slightly outperformed females. In both subject areas, the performance of White students was higher than that of Black or Hispanic students. (MJP)
